Your licence under the *Property and Stock Agents Act 2002* (the Act) has been **approved**. Please find your licence enclosed.

What do I need to know about my licence?

- Your lifetime licence number is 1113372.
- While employed by a principal licensee and supervised by a licensee in charge, this
 certificate allows you to perform work as a: Class 1 Agent-Auctioneers Accreditation Real
 Estate
 - Class 1 Agent-Strata Management
 - Class 1 Agent-Real Estate Business Broking
 - Class 1 Agent-Real Estate Sales or Leasing
- Your licence expires on 05/08/2026, unless it is suspended, cancelled or surrendered earlier. It is your responsibility to ensure that you renew your licence by its expiry date.
- You must advise NSW Fair Trading of any changes to your email, mobile or address details within 14 days.

What are the requirements of my licence?

The licence requirements you must comply with are:

- undertaking only those functions allowed by your licence class and category/s
- adhering to all restrictions and conditions attached to your licence
- ensuring you comply with all rules of conduct, supervision, and Continuing Professional Development requirements.

You are **not** authorised to release money from a general trust account, unless:

- you are the holder of a Class 1 licence: and
- you are appointed as a licensee in charge (LIC) by the principal licensee

Continuing Professional Development (CPD)

- You must complete all CPD requirements during each CPD year, which starts on 23
 March and ends 22 March. You must retain proof of attendance records or transcripts
 issued by the training provider for three years.
- The CPD requirements include both compulsory and elective topics and are outlined on the <u>Property Professionals</u> page of the Fair Trading website. It is important to note that compulsory CPD topics may only be delivered by approved providers, whose details can also be found on the website.

Failure to meet your CPD obligations is grounds for disciplinary action under the Act, which can include, among other things, monetary penalties, and suspension of your licence. If your licence is suspended, you will be unable to continue working as an agent.

Work Experience

- If you are a Class 2 licence holder and intend to apply for a Class 1 licence, you must retain proof that you have completed the work experience requirements set out in Schedule 1 of the Property and Stock Agents (Qualifications) Order 2019.
- You can download the work experience requirements <u>logbook</u> to record your achievements. Your licensee in charge must verify and sign off on your completed work experience over a two-year period. You should consider completing the logbook even if you do not intend to apply for a Class 1 licence soon.

Failure to comply with all licensing requirements can result in compliance action being taken against you.

How do I renew my licence?

You will receive a renewal application form approximately four weeks before the expiry date.

Please note the following information about renewing your licence:

- You will **not** be given a reminder notice. It is your responsibility to ensure the licence is renewed on time.
- If you do not receive the Renewal form approximately 2 weeks before the expiry date, you must contact us at businesslicensing@customerservice.nsw.gov.au for a replacement form.
- An expired licence can only be restored during a three-month period after its expiry date. If
 your licence expires, it will be an offence for you to be, act as, or exercise any of the
 functions of, an agent after this time. You will need to reapply if you want to work in the
 industry after a licence has passed its restoration period.
